

Goods and Services Tax and registration fees for Instruments and Searches

Since January 2003, SLA has been absorbing the Goods and Services Tax (GST) increase (1% in January 2003 and another 1% in January 2004). This was part of our effort to help the public and businesses to tide over the economic slowdown. Similarly, fees for registration of instruments have been maintained since 2002 despite higher operating costs.

With the improving economy and rising operating costs, we are unable to continue with the current arrangement.

Effective 1 April 2005, SLA will no longer absorb the 2% GST increase for registration of instruments and searches.

The fees for registration of instruments under the Land Titles Act and Land Titles (Strata) Act will be increased by \$3.00. However, this will take effect only on 1 August 2005. (Please see <u>Annex A</u> for the list of fee items).
